

Visitor's Acknowledgment of Risk

Each Rider must meet the following Essential Eligibility Criteria

- must be 6 years old
- weigh less than 225 lbs.
- be able to mount and dismount or be able to do so with little assistance from an employee
- maintain your own balance and sit stable while on the horse
- follow simple verbal instructions
- wear appropriate shoes (i.e. no sandals)
- ride with your cell phone off or on silent mode

- "Pony" Rides for the lil ones under 6 years of age

In consideration of the services of **CAMP RICHARDSON CORRAL**, their officers, agents, employees, and stockholders, and all other persons or entities associated with those businesses (hereinafter collectively referred to as **CAMP RICHARDSON CORRAL**) I agree as follows:

Although **CAMP RICHARDSON CORRAL** has taken reasonable steps to provide you with appropriate equipment and skilled guides so you may enjoy an activity for which you may not be skilled, we wish to remind you this activity is not without risk. Certain risk cannot be eliminated without destroying the unique character of this activity. The same elements that contribute to the character of this activity can be cause to loss or damage of your equipment, or accidental injury or illness, or in extreme cases, permanent trauma or death. We do not want to frighten you or reduce your enthusiasm for this activity, but we do think it is important for you to know in advance what to expect and to be informed of the inherent risks. The following describe some, but not all, of those risks.

- Horses could buck, lie down, kick, bite, rub, bolt or stumble.
- Saddles or bridles could break; saddles could slip.
- Insects could bite or sting either horse or rider.

I am aware that horseback riding entails risks of injury or death to myself. I understand the description of these risks is not complete and that other unknown or unanticipated risks may result in injury or death. I agree to assume responsibility for the risks identified herein and those risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of the risks.

I certify that I am fully capable of participating in this activity. Therefore, I assume full responsibility for myself, including my minor children, for bodily injury, death and loss of personal property and expenses thereof as a result of those inherent risks and dangers and of my negligence in participating in this activity.

I have read, understand and accept the terms and conditions stated herein and acknowledge that this Agreement shall be effective and binding upon myself, my heirs, assigns, personal representative and estate and for all members of my family, including all and any minors accompanying me.
